History:

Technological Initiative Pilsen (hereinafter TIP) is an association of legal entities that was founded in 2012. Case number L 6909 kept by the Regional Court in Pilsen. The reason for its foundation was to associate entities with significant developmental and technological potential in the Pilsen region in order to enhance mutual cooperation and competitiveness. The Association currently has nineteen members, including major companies of international significance, and other associated partners. The Association has also started a number of interesting projects that focus not only on securing benefits for members or partners, but also on supporting the entire region.

Vision:

An association of technological companies was formed on the basis of mutual benefit. The Association provides a suitable platform for meeting and managing the discussions of individual members. The Association coordinates procedures and promotes common interests. The Association cooperates with the public sector and educational institutions.





Activities 2019

General Meeting

On 04.06.2019 the first general meeting of TIP was held in 2019 at the University of West Bohemia in Pilsen. Representatives of the University of West Bohemia Mr. Mgr. Petr Kavalíř, Ph.D., MBA, Assoc. Ing. Luděk Hynčík Ph.D. and doc. Ing. Milan Honner presented the New Technologies research centre to the present TIP members. After the presentation, an excursion to individual laboratories took place.

In connection with the resignation of Mgr. Martin Kořínek, Ph.D. Stephan Kronmüller was elected Chairman and Member of the Board of Directors. During the negotiations, the annual report from 2018 was approved and activities planned for this year. Afterwards, the participants of the General Meeting decided on a sponsorship gift for Nvias.org worth 100,000 Czech crowns. At a subsequent meeting, the Board of Directors elected Dr. Ing. Mathias Eickhoff as a new chairman of the board.
